- Established initiatives and demonstrated commitment to providing opportunities to minority business enterprises
- Implemented an aggressive MBE Supplier/Vendor Recruitment Policy substantiated by an annually demonstrated percentage increase for the last 3-5 years
- Accrued a qualitative and quantitative record of providing opportunities to minority business enterprises
- Produced a track record of increased MBE involvement and participation dollars
- Developed initiatives to foster and advance SRMSDC goals and objectives
- Set an example for other SRMSDC corporate and government members to follow
